3. **Mode of despatch** : By road transport inclusive of all taxes , duties and insurance charges etc.
4. **Challans/Bills** : Three copies of challans should be submitted with every consignment, subsequently bills should be drawn in triplicate to the Cattle Feed Plant Berhampore, P.o. Cossimbazar Raj, Dist: Murshidabad along with the original challan duly signed and sealed by the concerned authority of the plant.
