Minutes of the Pre-bid meeting for procurement of BMCUs (0.5 KL-4 Nos, 1 KL-5 Nos, 2 KL-8 Nos) held on 21.08.2024 at 02.30 P.M at the Conference Hall of West Bengal Cooperative Milk Producers' Federation Ltd. in connection with NIT NO. WBARD/WBMF/BMCU/Diff.MU/NIT-05A (4th Call)/10/10(QA)/24-25 Date: 08.08.2024 (Tender ID: 2024_ARD_728589_1)

The pre-bid meeting in connection with NIT NO. WBARD/WBMF/BMCU/Diff.MU/NIT-05A (4th Call)/10/10(QA)/24-25 Date: 08.08.2024 (Tender ID: 2024_ARD_728589_1) for procurement of BMCUs (0.5 KL-4 Nos, 1 KL-5 Nos, 2 KL-8 Nos) has been held on 21.08.2024 at 02.30 P.M at the Conference Hall of West Bengal Cooperative Milk Producers' Federation Ltd.

The Addl. RCS, WBCMPF Ltd. presided over the meeting. Findings of the pre-bid meeting are as follows -

- 1. Only two parties namely (i) Serap India Pvt. Ltd. & (ii) Aviva Equipments Pvt. Ltd. participated in the pre-bid meeting.
- 2. The prospective bidders proposed some additions in "SPECIFICATION OF BMCU HAVING CAPACITY 0.5 KL, 1 KL, 2 KL WITH ACCESSORIES (INCLUDING DG SET)" vide page no. 11 to 23 of the NIT which are mentioned hereunder -
- (i) In page no.11 of the NIT under Clause No. 1.6 Subclause a) II. ""Tank shall be horizontal with an open able top cover' may be read as 'Tank shall be horizontal/vertical with an open able top cover' for 500 Lit and 1000 Lit BMCUs and for 2000 Lit BMCUs it may be read as 'Tank shall be horizontal with an open able top cover/closed type".
- (ii) For 2 KL BMCUs the pipelines & cables will be limited to -
 - (a) 38 mm L type filter 1 nos, Bend 38 mm bend 4 nos, 38 mm Expendables union 10 nos, 38 mm 3 way valve 3 nos, 38 mm pipe clamp 2 nos, 38 mm pipe line 12 metre, 51 butterfly valve 1 nos, 51/38 mm liner reducer 2 nos.
 - (b) Electric cable Earthing cable 4 sq. mm, 1 core 90 metre, 6 sq. mm 4 core 20 metre, 2.5 sq. mm 3 core 30 metre, 1.5 sq. mm 4 core 20 metre, 1 sq. mm 2 core 10 metre.
- (iii) For 1 KL BMCUs the pipelines & cables will be limited to -
 - (a) 38 mm L type filter 1 nos, Bend 38 mm bend 4 nos, 38 mm Expendables union 10 nos, 38 mm 3 way valve 2 nos, 38mm pipe clamp 2 nos, 38 mm pipe line 12 metre, 38 butter fly valve 2 nos

- (b) Electric cable Earthing cable 4 sq. mm, 1 core 90 metre, 2.5 sq. mm 3 core 30 metre, 1.5 sq. mm 4 core 20 metre, 1 sq. mm 2 core 10 metre.
- (iv) For 0.5 KL BMCUs the pipelines & cables will be limited to -
 - (a) 38 mm L type filter 1 nos, Bend 38 mm bend 4 nos, 38 mm Expendables union 10 nos, 38 mm 3 way valve 2 nos, 38 mm pipe clamp 2 nos, 38 mm pipe line 12 metre, 38 butter fly valve 2 nos.
 - (b) Electric cable Earthing cable 4 sq. mm, 1 core 90 metre, 2.5 sq. mm 3 core 30 metre, 1.5 sq. mm 4 core 20 metre, 1 sq. mm 2 core 10 metre.

The members present in the meeting discussed the proposed changes threadbare and upon discussion the proposed amendments were unanimously accepted for better clarity.
